Revised Order

Whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- 2. And whereas, the Shri Junagadh Kelavani Mandal, B.Ed. College 15 Bansidhar Society, Behind St Station Near Giriraj Society, Junagadh, Gujarat- 362002 by affidavit dt. 08.01.2015 has consented to come under new Regulations and sought for two basic units in **B.Ed**, which require additional facilities
- And whereas, it has been decided to permit the institution to have two basic units of 50 student each subject to the institution fulfilling following conditions namely,
 - The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
 - II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
 - III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
 - IV. In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted along with the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.
- 4. Now therefore, in the light of the above and in accordance with the NCTE Regulations, 2014, the Western Regional Committee (NCTE) hereby issues the revised recognition order to Shri Junagadh Kelavani Mandal, B.Ed. College 15 Bansidhar Society, Behind St Station Near Giriraj Society, Junagadh, Gujarat-362002 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

- 5. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.
- 6. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.
- 7. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

Sanctioned programmes along with annual intake in the institution:

b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

Name of faculty members who left or joined during the last, quarter:

 Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;

Fee charged from students;

f) Available infrastructural facilities;

g) Facilities added during the last quarter;

h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;

The affidavit with enclosure submitted along with application.

The institution shall be free to post additional relevant information. if it so desires.

k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

Sub:- No Objection Certificate (NOC) for the proposal to start College.

Sir,

I am directed to state that the Government of Gujarat has been decided to give NOC for starting B.Ed. College from 2004-05 with Saurashtra University by Shri Junagadh Kelvani Mandal, Junagadh as per direction given by Hon. High Court vide its oral order dated 25.6.;04 in the matter of MCA No. 967/2004 in SCA No. 3199 of 2004 filed by the said Trust.

- 2. The NOC is given on the following terms and conditions:-
 - 1. The college will be run on self-finance basis and no financial assistance will be provided by the State Government.
 - 2. The Institution shall have to accord sanction for the recognition / the admission of students only after the procurement of concurrence letter of NCTE, Bhopal.
 - 3. This is expressly subject to the recognition from NCTE, Bhopal for proposed B.Ed. College and the institution shall have to comply with the NCTE norms.
 - 4. The Trust shall have to obtain the No Objection Certificate from respective University to which the proposed B.Ed. College will be affiliated.
 - The admission to the students will be given strictly as per rules and regulations and with the previous approval of NCTE, Saurashtra University and also of the State Government etc..
 - 6. The structure of fees etc. will be as per Norms, Act, Rules, Regulations and Guidelines prescribed by NCTE, UGC, Saurashtra University and also of the State Government.
 - The institution will have to provide qualified staff, physical facilities and other facilities as laid down under NCTE Act, 1993.

 The State Government will issue the permission to start the institution only after obtaining the recognition from NCTE, Bhopal.

 The institution will have to complete all the facilities including hostel, within three months as per the NCTE norms and

report the same to the State Government.

10. The Trust shall have to obtain "No Objection Certificate" from respective University before commencement of above college and such certificate should be sent to the State Government.

- 11. An amount of Rs. 6,00,000/-(Rupees Six lakhs) to be deposited as a fixed deposit in the nationalized Bank for six years in the joint name of the President / Managing Trustee of said institute and the Registrar, Saurashtra University, Rajkot before the commencement of the course and Receipt of the said fixed deposit to be produced to the State Government and concerned university, the deposit with interest will have to be renewed at end of every six years.
- As per the affidavit furnished by the said trust the proposed college will be run on self-finance basis and no grant will be demanded from the State Government in future.
- 4. An early action in this regard is solicited.
